

## UNDERGROUND OPERATORS (JUMBO, LOADER, UG ELECTRICIAN, PLANT MECHANIC)

Perilya is seeking expressions of interest from experienced Jumbo Operators, Loader Operators/ Jumbo Offsiders, Underground Electricians and Plant Mechanics. For these positions it is essential that you have a broad range of underground mining experience. You will be multi-skilled on underground diesel equipment, a self-motivated worker and be able to work with minimum supervision.

To be successful in any of these roles you must enjoy working in a team environment, have excellent communication skills and demonstrate an ongoing commitment to safe work practices. You must also be able to proactively identify hazards and assess risks.

## Jumbo Operator and Loader Operator/ Jumbo Offsider

This role requires prior experience with Atlas Copco Jumbos and Underground Loader Operations. You must also have the relevant tickets. Relevant tickets include Light Vehicle, Jumbo Loader Ticket.

## **UG Electrical Tradesperson**

The main responsibilities of the Underground Electrical Tradesperson role include:

- Undertaking planned corrective maintenance tasks according to site and statutory requirements.
- Acting on breakdown maintenance requests
- Providing electrical maintenance support to maintain plant and equipment to current Australian Standards.
- Maintaining and installing new electrical infrastructure

To be successful in this role you must have an electrical trade certificate, a Senior First Aid Certificate and a NSW Qualified Supervisors certificate. Experience with low voltage electrical distribution systems, Low Voltage Rescue and Instrumentation and PLC will be considered advantageous. A High Voltage switching ticket would also be preferred as would prior Underground Experience.

## **Plant Mechanic**

Reporting to the Mobile Maintenance Supervisor this role will be responsible for the safe and on time completion of routine preventative, corrective repair and breakdown maintenance of Perilya's mobile fleet.

The main responsible of this role include:

- Undertaking planned, corrective maintenance tasks according to site and statutory requirements
- Acting on breakdown maintenance requests as prioritised by your Supervisor.
- Providing maintenance support to maintain equipment to current OEM Specifications.
- Advising appropriate personnel of arising issues, implications and improvements to assist the production process.
- Enforce Perilya safety standards and site policies.



To be successful in the role you are required to have a Plant Mechanic or Mechanical Fitting Trade Certificate. You must also have excellent communication skills and be able to work within both small and large teams. It is highly desired, that you have at least two years current experience in the Plant Mechanic or Fitting trade. Particular experience in the maintenance of underground drill rigs, loaders, trucks and ancillary fleet will be well regarded.
